**Application:**

Outbound Prepaid single-line service for shipments originating at the account location listed above.  
Outbound Collect single-line service for shipments originating at the account location listed above.  
Third Party single-line service when shipment originates at the account location listed above.

Tariff rates apply only to shipments moving within the continental United States. Shipments originating at or destined to points in Alaska, Hawaii, Puerto Rico, the Virgin Islands, Canada or Mexico must reference a TurnKey quote.

**Jointline shipments must reference a Turnkey quote.**

Inbound Collect service (for return shipments) must reference a TurnKey quote.

**Restrictions and Additional Services:**

**Except as otherwise outlined, provisions of this pricing will be subject to all accessorial rules and charges provided in the ABFS 111 (series) Tariff and the ABF 631 Tariff.**

1. Rates only apply in connection with the commodity listed above in various weights & dimensions.
2. After hours, weekend, or specific time deliveries are not included in the price shown above.
3. Shipments requiring re-delivery will be assessed an additional fee per shipment.
4. Maximum weight per individual item is **400** pounds, pallets of individual items may weigh more.
5. Rates will not apply to points which require, in part, transportation by ferry or vessel to reach destination.
6. Rates cover a total delivery time not exceeding **75** minutes for **two men**. Services in excess of such will be provided at an additional rate as outlined in the ABF **631** Tariff.
7. If no elevator is available, ABF does not obligate itself to performing delivery to flights other than the ground level; however, if ABF deems itself capable of performing delivery to other flights, an additional charge will apply beyond the first two flights.
8. Provisions will be subject to a minimum rated weight calculated at **1.0** pounds per cubic foot.
9. Floor Covering / Protection will be provided at an additional charge when required.
10. ABF liability shall be subject to the provisions of Item 780-1 of ABFS 111 Series.
11. When a time specific pick up or delivery is required, an additional charge will apply.
12. Tariff rates do not include storage. If storage is required an additional charge may apply.
13. For TurnKey rates to apply, the Shipper must specify "ABF TurnKey Service Requested" in the original, unmodified bill of lading at time of shipment.
14. The Fuel Surcharge contained in Item 161 of ABFS 111 rules will apply.
